# Stevens Soil & Water Conservation District Regular Meeting Minutes Tuesday, April 12, 2022 9:30 a.m. SWCD Office

- I. Chair Anderson called the regular meeting to order at 9:30 a.m. Board members present: Anderson, Feuchtenberger, Fynboh, Goodnough, Lonergan. Staff present: Solemsaas, Staebler. Others present: Jeanne Ennen, County Commissioner; Melissa McCann, NRCS.
- II. Supervisor Goodnough moved to approve the agenda. Second by Supervisor Fynboh. Passed unanimously.

## III. Reports

- A. Melissa McCann, NRCS, gave a program update. She discussed application periods and she is working on CSP rankings, and CRP contracts. The LWG group will be meeting during the next board meeting. She was attempting to hold this meeting in conjunction with other counties, but they were not interested.
- B. Commissioner Ennen reported that the final hearings for Ditches 5 & 18 happened at the end of March. They are working on getting the bonding to go through for Ditch 25. They have been attending township meetings recently.
- C. Additions to written staff reports
  - a. Solemsaas reported that the Chippewa River 1W1P public meeting held last week was well attended. Supervisor Feuchtenberger also attended. He recently attended MASWCD Legislative Day with Supervisor Lonergan. There was a small article in the paper. The SWCD Aids bill is moving through.
  - b. Erickson discussed pending buffer compliance agreements with landowners. The county is preparing to charge landowners not in compliance with misdemeanors. Continued compliance on other parcels will be monitored continuously. He also updated the board on the RIM encroachment issue that the state has been working on, as well as an ownership issue on another parcel.
- IV. Fynboh moved to approve the minutes from the March Regular Meeting. Second by Goodnough. Passed unanimously.
