- I. Chair Anderson called the regular meeting to order at 9:30 a.m. Board members present: Anderson, Feuchtenberger, Fynboh, Goodnough, Lonergan. Staff present: Solemsaas, Staebler. Others present: Melissa McCann, NRCS.
- II. Supervisor Feuchtenberger moved to approve the agenda. Second by Supervisor Fynboh. Passed unanimously.

III. Reports

- A. Melissa McCann, NRCS, gave a program update and noted staffing changes. They hope to be able to do a direct hire in mid summer. She is looking for board member participation on a national level civil rights review to come. She reviewed current civil rights information and obtained board member signatures on the Affirmation of Civil Rights Review. She also discussed the desire to look for ways to reach additional underserved individuals in our area.
- B. Commissioner Ennen was unable to attend due to a commissioner's meeting.
- C. Additions to written staff reports
 - a. Solemsaas gave out a sheet of talking points related to the SWCD Aid proposal in the legislature. This funding would replace Local Capacity funding and other state grants and would be evenly distributed among the state's SWCDs. He and Supervisor Lonergan will be meeting with legislators Backer, Westrom and Anderson over the next two days while attending the MASWCD Legislative Briefing & Day at the Capitol. He also talked about a potential contribution agreement with NRCS for the completion of about 50 CRP plans. He has been looking into leasing Fendt tractors from a dealer in Fergus Falls. He attended a meeting with the county about the Pictometry GIS layer. They will have the county flown again for new images. He handed out laminated informational booklets about several recent projects within the county.
- IV. Fynboh moved to approve the minutes from the February Regular Meeting. Second by Feuchtenberger. Passed unanimously.
